APPOINTMENT SCHEDULING AND SELF-SCHEDULING

Columbus-area software company Strategic Government Solutions has partnered with Amazon, Lower Lights Christian Health Center (LLCHC) to deliver the COVID-19 Patient Scheduling Solution in Franklin and Union Counties in response to the pandemic.

With healthcare providers in Ohio increasingly overwhelmed with patients in need of testing, a need to expand testing to remote sites became necessary. After Ohio Governor Mike DeWine announced that coronavirus tests are now available to all citizens in the state, LLCHC turned to AWS and Strategic Government Solutions for a software solution.

For organizers and facilitators, the solution can sync with resources (e.g., number of test kits available) in real-time to ensure a supply and demand match for open testing slots; however, LLCHC preferred an easy to use list and avoid integration efforts. Facilitators can use the app on any mobile device to track appointments and perform fast check-ins.
